General Guidelines

*Art must have water depicted- a named lake, pond, river or stream in Michigan. It can include people, wildlife and flora. It can contain structures such as a lighthouse, barns, boats, bridges and more. The theme is "Water Wonderland of Michigan" so make sure your art depicts that. The registration will ask you to name where your subject is such as – River Raisin, Monroe, Mi., or Lake Michigan, Muskegon, Mi.

Artists do not have to live in Michigan to participate, the subject has to be in Michigan.

*Mediums: Oil, Acrylic, Watercolor, Ink, Pencil, Charcoal, Pastel, Scratch Board, Wood Burning, Wood Carving, Stained Glass, Sculpture, Pottery/Ceramics, Mixed Media and Photography. Other mediums may be accepted if prior authorization is obtained. Contact Darlene at <u>dlbelair10@gmail.com</u> if you have questions concerning other mediums.

*Original art only, no prints, posters, abstracts, or duplicated class room art. <u>Exception:</u> photography prints.

*Each artist may exhibit up to three (3) pieces of art.

*Maximum size **36** inches wide x **36** inches long, including the frame, if framed. Canvas paintings must be framed, or gallery wrapped. Saw tooth hangers are not acceptable, and art should be wired and ready to hang. Sculptures must be able to set on a table or free standing on the floor and easily moved by one person, without mechanical assistance (maximum weight 30 lbs.). Stained glass must set on a table or on a floor easel; if it needs a special easel please provide one. The Battlefield <u>may</u> have easels available for your use.

*Artwork deemed not suitable or not within guidelines may be rejected by the National Park Service or the curators.

Sales Related Information

*On the registration form <u>PLEASE PRINT</u> your name, title of art, medium, location of the subject and price you are asking or NFS (not for sale) if you do not wish to sell. A 15% added commission will be added to your sale price. The final price or NFS will be on the printed on the Title card by your art work. If sold the 15% commission will go to the Battlefield's Education Center. If the Battlefield Foundation (RRNBPF) purchases a piece of your art, they will pay the artist's price.

*If your art is sold during the run of the exhibition, the RRNBPF will handle the sales transaction(s). Buyers may pick up their purchased art at the conclusion of the exhibition, and will be reminded by the curators (via email and/or phone.) If the art work needs to be shipped the artist will be responsible for making arrangements with the buyer. Artists will be notified upon sale of their art (via email and/or phone) and a check will be issued to the artist by the end of the exhibition. The RRNBPF has first rights of purchase if art is for sale.

*Art purchased by the RRNBPF or the National Park Service will require releasing rights of the art work to be reproduced by the RRNBPF or the National Park Service for purposes of advancing the educational programming of the Battlefield.

*Artist contact information will not be published or otherwise given without the permission of the artist.

Educational Programming at the River Raisin National Battlefield Park

We are grateful for the support from the artists and our community and it's collective interest in being a part of "**Beautiful Bountiful Michigan**" exhibitions. We are busy working on educational programming such as student and adult art/craft classes, demonstrations and student art displays.

Programs that the Battlefield have previously presented include calligraphy, punched tin, Native American crafts, flint knapping, corn husk dolls, and teaching about the way the settlers in Frenchtown lived. The craft programs directly reflect the way things were done and made in the Frenchtown Settlement in the early 1800's. The Wildlife art teaches what animals lived in Michigan, and the Flora art will teach what plants and trees thrived here, and how they were used for food, medicinal purposes, building and everyday survival. Also through the Park's kayaking program visitors may see some of the wildlife and flora, and experience what the Frenchtown settlers did.

Spring of 2019 there were more than 3,000 students that came to the Park for Field trips, and 11,000 over the course of the entire year, to learn about the Untold Story of the War of 1812!

We hope that through our art we can educate all about the animals, plant life and places in our "**Beautiful Bountiful Michigan**." Thank you once more for joining us!
